I. POLICY STATEMENT

The Department of Child Safety (DCS) is committed to pursuing a safe and healthy environment for families. This policy outlines the considerations for bed capacity in a licensed foster home.

II. APPLICABILITY

This policy applies to all applicants, licensees, private licensing agencies, and the employees of the Office of Licensing and Regulation.

IV. DEFINITIONS

Department or DCS: The Arizona Department of Child Safety.

Director: The Director of the Arizona Department of Child Safety.

<u>Fitness</u>: the ability of an applicant or foster parent to provide a safe and nurturing environment for all children in the home and comply with the foster home licensing requirements.

<u>High Needs Foster Care (HNFC)</u>: A family-based placement option in which care is provided by a licensed foster parent who has received specialized training within a support system of clinical and consultative services to children with serious behavioral or emotional needs. This term is often used synonymously with Therapeutic Foster Care.

<u>Medically Complex</u>: a class of foster home in which the licensed foster parent is certified to provide care to a foster child identified by the Department as requiring special care for medically complex needs.

<u>Office of Licensing and Regulation (OLR)</u>: The administration within DCS that is responsible for reviewing and evaluating application for licensure; supervising and monitoring licensees; and completing all official licensing actions, including issuing, denying, amending, suspending, and revoking a license.

V. POLICY

- A. When an applicant applies to provide foster care, OLR will evaluate each application based on the fitness of each individual foster home. Factors will include but are not limited to:
 - 1. Age range;
 - 2. Beds in the home;

- 3. Fitness of the family;
- 4. Transportation capabilities;
- 5. Kinship waivers; and
- 6. Agency recommendation
- B. Regular foster home capacity has a population of five foster care placements with no more than 8 total children in the home. A maximum of 3 collectively out of the available foster care beds can be used for medically complex, therapeutic, or children with higher needs.

VI. PROCEDURES

- A. Prior to the submission of an application, the private licensing agency needs to ensure that the application provides a detailed account of the applicant or foster parent's fitness and capabilities of caring for children with high needs and the population desired.
- B. OLR will communicate with private licensing agencies, as necessary, regarding any fitness or capability concerns.
