### Pick Up Requests for DCS Court Wards:

- If the child is in DCS custody and a request is made for DCS to pick up the child, a Status Communication will be generated.
- Select Pick Up of Court Ward as the Intake Type.

## Request for Pick Up Matrix

### Purpose of Request for Pick Up Matrix:

The purpose of this information (matrix) is to clarify the action the Hotline will take when DCS receives a request to pick up a child. Requests for DCS to pick up a child are not always appropriate for DCS involvement. The matrix below outlines MOST of these circumstances. However, understand that there will be outliers that are not listed here, and in those circumstances, the Intake Specialist will call the Help Queue for additional guidance.
