

## NYTD Services Matrix

Independent Living Needs Assessment: Casey Life skills assessment	Documentation of CLSA or another appropriate assessment, provided by a DCS contracted service ( STA, LifeSet, EFC Coaching, Transitional Housing, Education Specialist, Youth Advocacy Specialist, DCS placement, ETV ).
Academic Support: High School/GED	Documentation in case shows that a DCS contracted service (STA, LifeSet, EFC Coaching, Transitional Housing, Education Specialist, Youth Advocacy Specialist, DCS placement, ETV) taught or assisted youth with academic support for high school or GED attainment.
Post-secondary educational support	Documentation in case shows that a DCS contracted service (STA, LifeSet, EFC Coaching, Transitional Housing, Education Specialist, Youth Advocacy Specialist, DCS placement, ETV) taught or assisted youth with academic support for post-secondary or vocational training.
Career Preparation	Documentation in case shows that a DCS contracted service (STA, LifeSet, EFC Coaching, Transitional Housing, Education Specialist, Youth Advocacy Specialist, DCS placement, ETV) assisted youth with career preparation.
Employment or vocational program	AZ does not have any DCS or Chafee funded Vocational or employment programs.
Budget and Financial Management	Documentation in case shows that a DCS contracted service (STA, LifeSet, EFC Coaching, Transitional Housing, Education Specialist, Youth Advocacy Specialist, DCS placement, ETV) ) taught or assisted youth with budget and financial management (subsidy agreement, savings match, etc.).
Housing and home management	Documentation in case shows that a DCS contracted service (STA, LifeSet, EFC Coaching, Transitional Housing, Education Specialist, Youth Advocacy Specialist, DCS placement, ETV) taught or assisted youth with housing or home management.
Health education and risk prevention	Documentation in case shows that a DCS contracted service (STA, LifeSet, EFC Coaching, Transitional Housing, Education Specialist, Youth Advocacy Specialist, DCS placement, ETV) taught or assisted youth with health education and risk prevention.
Family support and healthy marriage education	Documentation in case shows that a DCS contracted service (STA, LifeSet, EFC Coaching, Transitional Housing, Education Specialist, Youth Advocacy Specialist, DCS placement, ETV) taught or assisted youth with family support/health marriage education.
Mentoring	Youth has mentor through a DCS Youth Advocacy Specialist, STA Navigator or LifeSet specialist.
Supervised Independent Living	Y.A. is over 18 and in DCS Subsidy program, TILP, living in dorm paid for with ETV. These are auto populated through Guardian payments. If payment is made outside of Guardian, staff should enter (very rarely this would need to be done).
Room and board financial assistance	Y.A. is in any DCS paid placement, including, over 18 and received financial payment through paid placement, Subsidy, TILP, ETV for room and board. These are auto populated through Guardian payments. If payment is made outside of Guardian, staff should enter (very rarely this would need to be done).
Educational Financial Assistance	Payment provided to youth for activities/fees for secondary or post-secondary education: tuition, books, testing, etc.
Other financial assistance	Y.A. received financial services that don't meet any of the above categories: driving school, normalcy activities, work clothing, etc.

Purpose: The NYTD Services matrix is intended to facilitate a conversation regarding the appropriate responses for the Guardian NYTD screen. The NYTD screen is completed at least once during each reporting period: Oct. 1<sup>st</sup>-March 31<sup>st</sup> and April 1<sup>st</sup>-Sept. 30<sup>th</sup>. Any youth who had a Chafee funded service (meaning that DCS, a DCS caregiver, or DCS contractor provided the description) needs a completed screen. DCS Specialists and EFC Coaches enter responses into the NYTD service screen ONLY for Chafee funded services by: a DCS employee/caregiver, DCS contracted service (STA, TILP, LifeSet, EFC Coaching, Transitional Housing, Youth Advocacy Specialist), or Education and Training Voucher (ETV).
